## Re. Urgent SSSI Designation of Swanscombe Peninsula

We hardly need to remind you that biodiversity is in crisis, or that wildlife populations, particularly of insects, are in steep decline. We are sure you are also aware that many habitats and specialist species are increasingly rare and their fragmented populations are at risk of extinction.

Many brownfields in the Thames Estuary have become harbours for rare and threatened estuarine and coastal species that were once found more widely. But they have not been safe harbours, we have seen many sites destroyed, and only two extensive areas of Open Mosaic Habitat on Previously Developed land in the area remain intact and free from development permissions — one, Canvey Wick in Essex, is an SSSI and the other, Swanscombe Peninsula, in Kent, is imminently threatened with destruction to make way for a theme park.

The purpose of SSSIs is to safeguard, for present and future generations, the diversity and geographic range of habitats, species, and geological and physiographical features, and where Natural England is of the opinion that land is of special interest by reason of its flora, fauna, or geological or physiographical features, it is the duty of Natural England to designate an SSSI.

Recent surveys have revealed that the Swanscombe Peninsula is unique and home to more red-listed and conservation concern species than any other site in the UK. The attached "Rationale for the SSSI designation of the Swanscombe Peninsula" (Buglife, Kent Wildlife Trust and RSPB 2021) demonstrates beyond a shadow of doubt that the site is of very high national significance for a number of biological features. There is an opportunity to put in place a blue-green belt of wildlife protected land stretching across the Thames from Swanscombe to Thurrock.

In our experience there has rarely, if ever, been a stronger case made for the SSSI designation and protection of a wildlife site. We urge you to urgently consider the evidence and recognise the special interest of the Swanscombe Peninsula. We trust that Natural England will be resolute in its impartial consideration of this site and recognise that its protection is in the national interest. It is important not to condone any development that would damage any part of the site, as this would jeopardise the integrity and importance of the site. The whole site should be designated as an SSSI as soon as possible.

We would be pleased to discuss the case with you and assist with any further information that you may require. We look forward to hearing about progress on this matter.
